

Privacy Policy - The Wings India

“The Wings India” and its affiliates respect your privacy and is of utmost importance to us. Please read the following to learn more about our Privacy Policy. This Policy applies to “The Wings India” website and services that display or provide links to our audience.

- This Policy describes how “The Wings India” processes your personal data. Personal data means any data that, either on its own or jointly with other data, can be used to identify a natural person. You directly provide us with such data when you use our websites, products, or services, or interact with us by, for example, creating an account on our website or contacting us for support.

- We may also obtain data by recording how you interact with our websites, products, or services. For example, we may use technologies like cookies or receive user data from software running on your device. As permitted by law, we may also obtain data from public and commercial third-party sources, for example, purchasing statistics from other companies to support our services.

- We may use your personal data for the following purposes:
 1. Creating an individual/organization’s account.
 2. Fulfilling your service or demo requests like taking you through what we do at “The Wings India”.
 3. Participating in “The Wings India” onsite or virtual activities.
 4. Fulfilling your requests for changes or providing you with the requested information (such as marketing materials for products and services) and providing technical support.
 5. Contacting you with your consent; sending you information about products and services that may interest you; inviting you to participate in “The Wings India” activities (including promotional activities), market surveys, or satisfaction surveys; or sending you marketing information. If you do not want to receive these types of information, you can opt out at any time.
 6. Sending you important notices and updates regarding “The Wings India”
 7. Providing you with customized content and channels to communicate.
 8. Improving our products and services through internal audits, data analysis, and research.
 9. Analyzing the efficiency of our business operations.
 10. Troubleshooting when you send us any concerns regarding accessing “The Wings India”

website.

11. Ensuring the security of our products, services and customers or users.

12. Complying with and enforcing applicable legal requirements, industry standards and our policies.

- The personal data we collect may include name, gender, enterprise name, job position, postal and email addresses, phone number, login information, photos, and other information, depending on how you interact with “The Wings India”, for example, the website you visit or the products and services that you use. We also collect the information you provide to us and the content of messages you send us, such as the query information you provide, or the questions or information you provide for customer service support. We would like to ensure that anything you share with us strictly remains within the organization’s records and is shared, only with our client’s consent.
- We will try to isolate your personal data from third parties but we are not liable in case of any frauds or fake profiles made in the name of “The Wings India”.
- We also do not entertain any requests if our team member personally deals with your work tasks. It is between you and the concerned person. “The Wings India” have no responsibility in case of any fraud dealings or cheating.
- To ensure our website works correctly, we may at times place a small piece of data known as a cookie on your computer or mobile device. A cookie is a text file stored by a web server on a computer or mobile device. The content of a cookie can be retrieved or read only by the server that creates the cookie. The text in a cookie often consists of identifiers, site names, and some numbers and characters. Cookies are unique to the browsers or mobile applications you use, and enable websites to store data such as your preferences or items in your cart. Like many other websites or Internet service providers, “The Wings India” uses cookies to improve user experience. Session cookies are deleted after each visit, while persistent cookies remain in place across multiple visits. Cookies allow
websites to remember your settings such as language, font size on your computer or mobile device, or other browser preferences. This means that a user does not need to reset preferences for every visit. On the contrary, if cookies are not used, websites will treat you

as a new visitor every time you load a web page. For example, if you are redirected to another web page from a website you are already logged in to and then return to the original website, it will not recognize you and you must log in again.
